OF
GREENFIELD PUBLIC SCHOOL SOCIETY,

1. The name of the Society shall be "Greenfield Public School Society".
2. The Registered office of the Society will be within the Union Territory of Delhi at P-11, Durga Chaudhary, Delhi-32.
3. The objects for which the society is established are:-
 - (i) To establish schools with English and Hindi medium in particular Nursery and Kindergarten schools on public school lines.
 - (ii) To start extra cultural activities amongst students on public school lines.
 - (iii) To promote literature, science, and fine arts and the diffusion of other useful knowledge amongst students.
 - (iv) To establish and maintain educational institutions for the purpose of imparting education to boys and girls in various subjects as specified by the Delhi Education Department.
 - (v) To develop the mental, moral and physical facilities of the students and to promote sense of discipline amongst students.
 - (vi) To inculcate in the students, the spirit of patriotism and self-sacrifice, respect for law and order and genuine regard for elders.
 - (vii) To raise funds for the above aims and objects and control their investments and expenditure and to generally do all such things as may be necessary or auxiliary to carry out the aforesaid objects.
 - (viii) To open libraries and reading - rooms for students.

RULES AND REGULATIONS
OF
GREENFIELD PUBLIC SCHOOL SOCIETY

1. MEMBERSHIP

The membership of the society will be open to every adult person who agrees with the aims and objects of the Society.

2. MEMBERSHIP FEE.

Each member shall pay admission fee of Rs. 1/- only once during the membership and Rs. 10/- as his annual subscription.

3. MANAGEMENT OF SOCIETY.

The management of the Society will be the function of the Managing Committee consisting of the Office-bearers and eight members:-

- (i) President.
- (ii) Vice-President.
- (iii) Secretary.
- (iv) The Principal of the Greenfield Public School, P-11, Naveen Shahdara, Delhi-32.
- (v) Two representatives of the parents of students of Greenfield Public School, P-11, Naveen Shahdara, Delhi-32.
- (vi) Five persons who are interested in the educational activities or who are residents of the locality.

4. ELECTIONS.

The election of the office-bearers of the Society will be held once every third year in the General Meeting of the School.

5. DATE OF GENERAL MEETINGS.

The notice of the place and date of the General Meeting will be issued to all the existing members by post.

6. RIGHTS OF VOTING.

No person who is in arrears of yearly subscription will be entitled to vote in the Annual General Meeting.

OPEN VOTE.

The voting will be by show of hands in case of a tie the President will have the right of the casting vote.

8. THE DUTIES AND FUNCTIONS OF THE OFFICE-BEARERS.

PRESIDENT.

The president will preside over the meetings of the Society and will have the right of general control over the working of the Society. He will confirm the proceedings of the last meeting of the Society.

VICE-PRESIDENT.

The Vice-President will perform all the functions & carry out the duties of the President in case of the absence of the President.

SECRETARY.

The Secretary will be responsible for General management and the working of the School and the Society. Subject to the instructions of the Managing Committee, he will call meeting of the Managing Committee. He will deposit money in the Bank and withdraw the same. He will also maintain regular accounts of the School and the Society.

CHIEF PATRON.

An eminent person of high public status will be elected as the Chief Patron of the Society. He will be exempted from the payment of admission fee and other charges.

The present Managing Committee will continue to function as Managing Committee till the elections are held within a period of three years of the Registration of the Society.
